Code of Conduct and Responsibility Agreement

2018

By signing this code of conduct I acknowledge that I will abide by all rules, regulations and responsibility outlined here in.

Rules

- 1. No smoking on property
- 2. No running around horses
- 3. No yelling or rough housing around on the property
- 4. Appropriate foot wear must be worn while working around horses no sandals in the barn at any time
- 5. Helmets must be worn while riding
- 6. No horsing around while riding or around the horses
- 7. No person under 16 years of age may be on the property unsupervised by an adult
- 8. All riders under 16 years of age must be supervised by an adult while riding
- 9. All riders 18 years or younger may not ride on or from the farm unless another person age 18 or older is on the premises and is aware that you are riding
- 10. No dogs brought to the property as barking or other disturbances can spook the horses
- 11. Respectful language and behavior is expected of all riders and any visitors on the property

Regulations

- 1. Listen and follow all instructions given by Crystal or other coach(s) immediately
- 2. Payment is due monthly prior to the first lesson of the month unless a package has been purchased
- 3. **24 hrs notice must be given to cancel a lesson**, lessons will than be carried over to next month/end of package
- 4. If less than 24 hr notice is given you will be charged in full for the missed lesson. **NO EXCEPTIONS**.
- 5. Respect barn hours: Open from 9am to 9pm all days except Tuesday. The barn is closed on Tuesday
- 6. Close all doors in the winter
- 7. Turn off lights when building is not in use
- 8. Please park you vehicle by the barn in such a way as not to block other vehicles
- 9. Payment is placed in the designated payment box on the day of your lesson failure results in a \$5 fine
- 10. Please note that all rider/farm correspondences regarding farm news, lesson cancelations, upcoming events etc. will be sent out by email
- 11. On average lessons will NOT be cancelled due to poor weather or statutory holidays

Responsibilities (Student)

- 1. Listen and follow instructions carefully to ensure your safety and that of others and the horses
- 2. Respect horses, equipment, fellow students, parents and the coach
- 3. Give your best effort during every lesson, work hard
- 4. Clean-up after your horse: this includes picking up poop in the aisle and the arena, sweeping the barn floor, and putting away all equipment in its original place
- 5. Have Fun

Responsibilities (Parent)

- 1. Please **do not** talk to the child/rider while they are riding as this distracts them and causes an accident
- 2. Please support the decisions made by coach and encourage you child to do the same
- 3. In case of accident please allow Crystal/coach to evaluate the situation prior to rushing over to your child, this will ensure your safety and your child's safety
- 4. Monitor any guests that have come with you to the farm and ensure that they follow rules and regulations outline above
- 5. Please note you are responsible for the safety of your guests while they are on our property
